- Revisiting bylaws for business members approval
  - Meant to remove total Board discretion in approving and terminating business memberships by eliminating board approval for business memberships and providing specific conditions for termination. Only lawful businesses are eligible for business memberships. It was not offered to eliminate discriminatory language--only a process that could result in arbitrary and unlawful discrimination.
    - Don't want to be judge and jury
      - However convictions can take years
      - Known shady practices of businesses around HDNA
